On Saturday, September 16, 2023, we will be hosting the **David Warsen Legacy Golf Outing**, in honor of S02 Navy SEAL David J. Warsen, who was lost in Afghanistan on August 16, 2012.

Starting in 2013, with the support of sponsoring companies, participants, and other fundraising events over the last 7+ years, we have raised over \$175,000! One of the main objectives of the David Warsen Legacy Foundation is to bring the community together to remember and celebrate David's life. The Foundation distributes funds to impact 4 focus areas:

- Care packages filled with clothing, food, and special notes from home, to deployed Navy SEALs and other Military members. In 2013 we sent over 100 care packages to deployed military members, and each subsequent year we have received many more requests. Our "packing night" takes place in November, and it is a place where participants can directly impact these deployed service members, truly a special event for all involved.
- We sponsor youth soccer players whose families may struggle financially. We have assisted multiple children, providing their entry fee, shoes, shin guards, and more over the last 6 years. David loved soccer, and this is a special connection for his family to assist those who may not be able to participate without some help.
- In cooperation with Nick Foster, the David Warsen Service Scholarships were established. Each May they are awarded to a graduating Senior(s) at David's high school - East Kentwood High School, in Kentwood, Michigan.
- There are many opportunities for the David Warsen Legacy Foundation to contribute thru random acts of kindness. For example, we have helped cover travel expenses for a family to seek urgent out-of-state medical assistance for their child. There are many who have a one-time need, and we seek to be a resource for them. We need your help to build on the success that has already been experienced.
